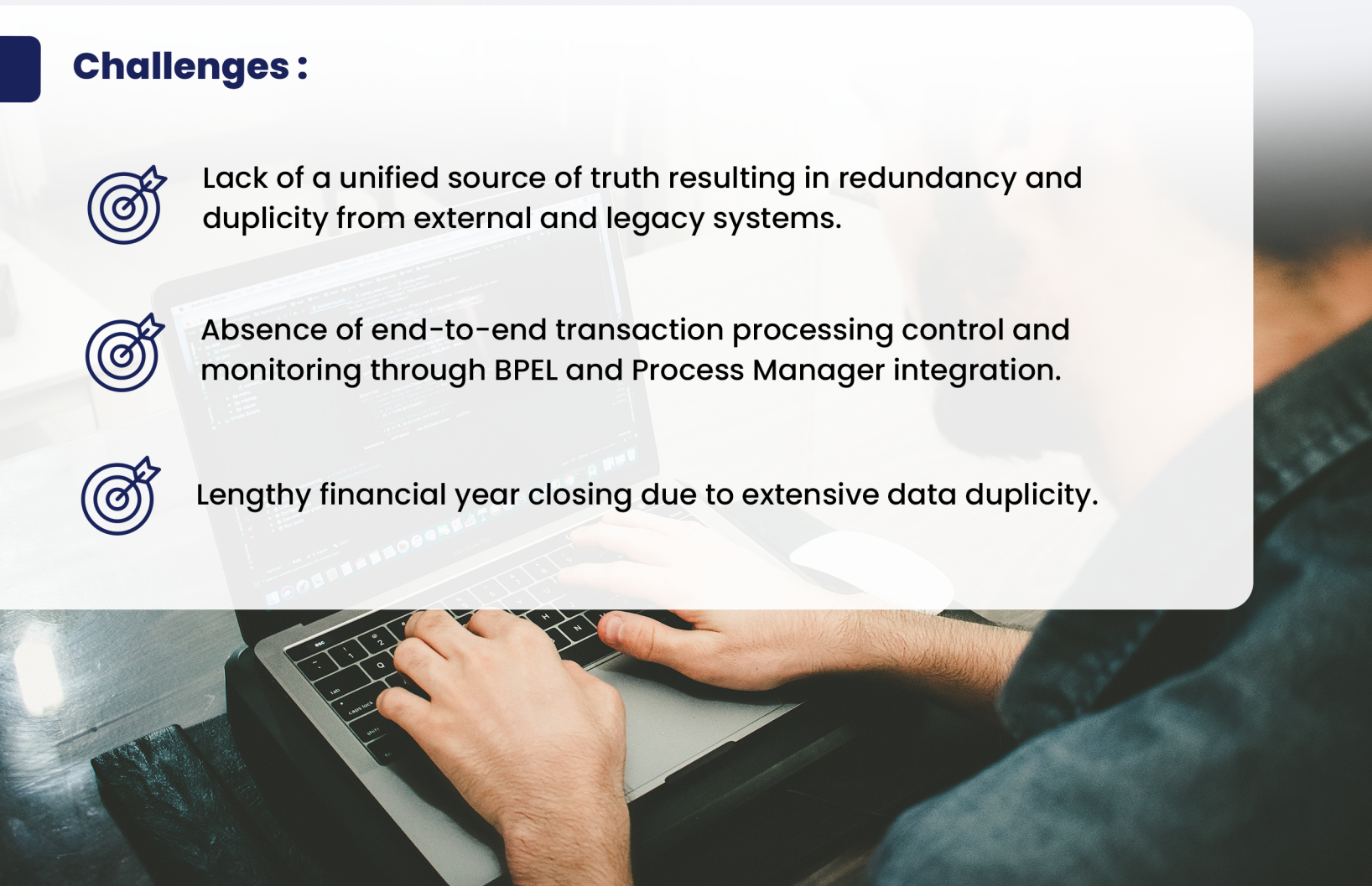
Lack of a unified source of truth resulting in redundancy and duplicity from external and legacy systems.

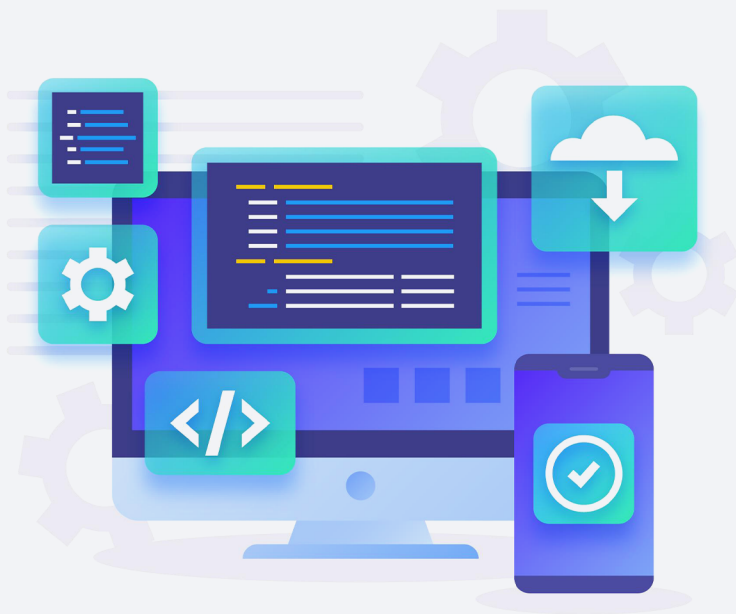
